THE FOLLOWING REGULATIONS APPLY TO BEACH BON FIRES

1. No pallets or wood with nails allowed.
2. No glass containers are allowed on the beach or seawall area.
3. The fire will be located at least 100 feet south of the seawall.
4. The fire will be located at least 100 feet from any wooden structure (beach hut, pier, building) or erosion control area (grass or fence).
5. The fire will be kept small and under control at all times (3 ft. high 6 ft. wide).
6. The fire shall be constantly attended by a competent person (18 years old) until the fire is completely extinguished. Do not cover with sand.
7. All debris will be placed in container or removed before leaving beach.
8. No fires are allowed in Bird Sanctuary Areas.

By signing below, the applicant agrees that the City of _____ and/or Harrison County will not be held liable for any damage or other liabilities incurred as a result of the fire. This permit may be revoked when in the opinion of the Harrison County Sand Beach Department that atmospheric conditions, or local circumstances, make the fire dangerous. The permit fee of \$25.00 is non-refundable. Failure to adhere to the above regulations could result in a fine up to \$500.00 or thirty (30) days in jail. (Section IV Harrison County Sand Beach Ordinance)

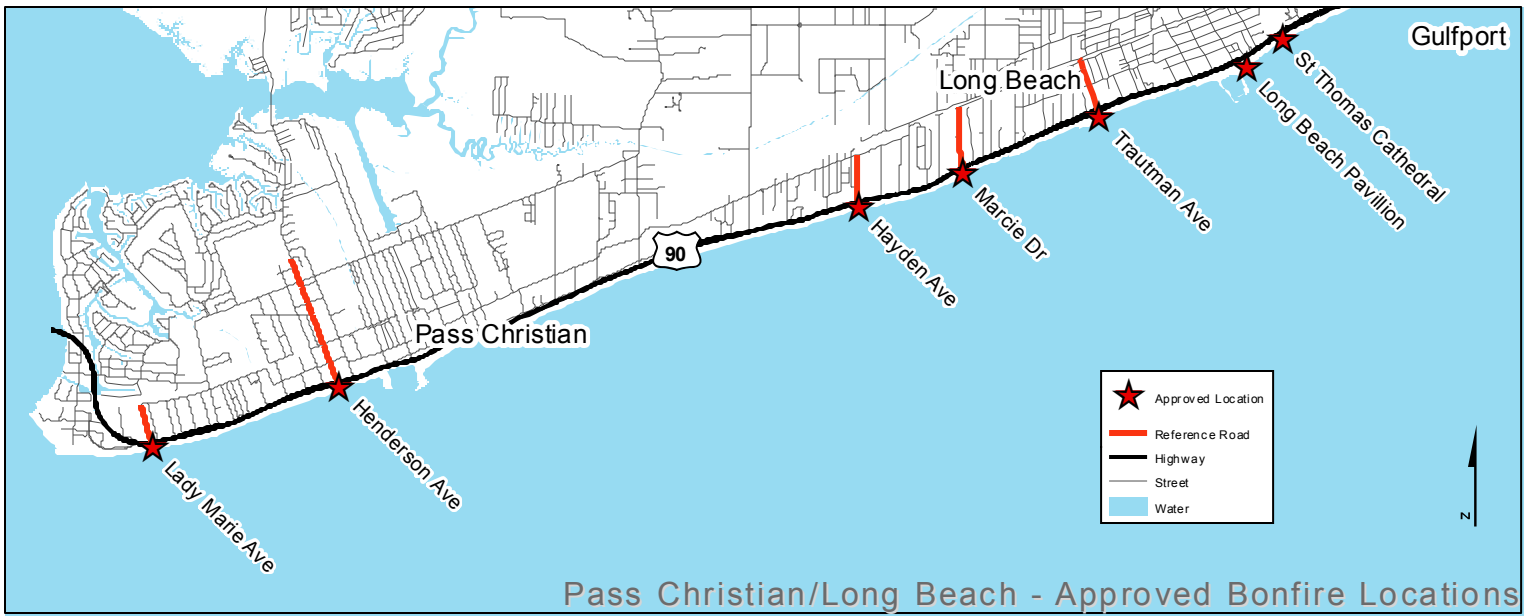

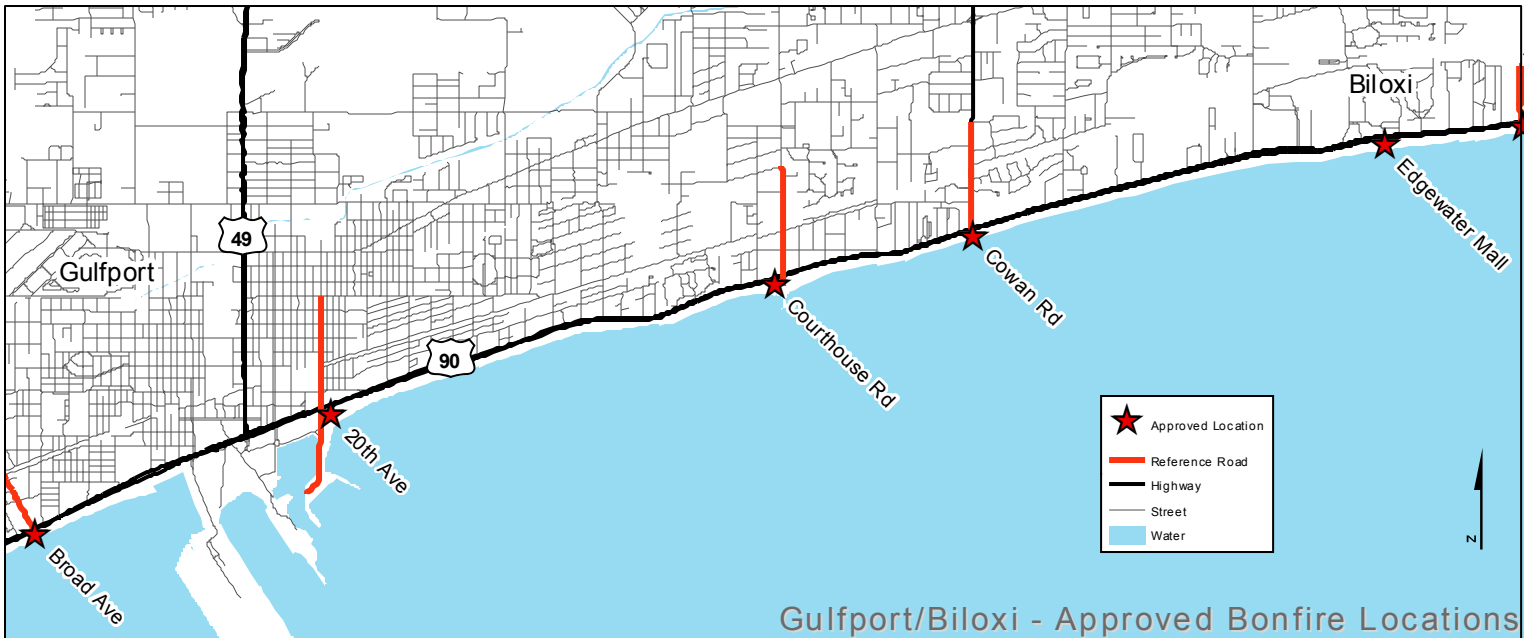

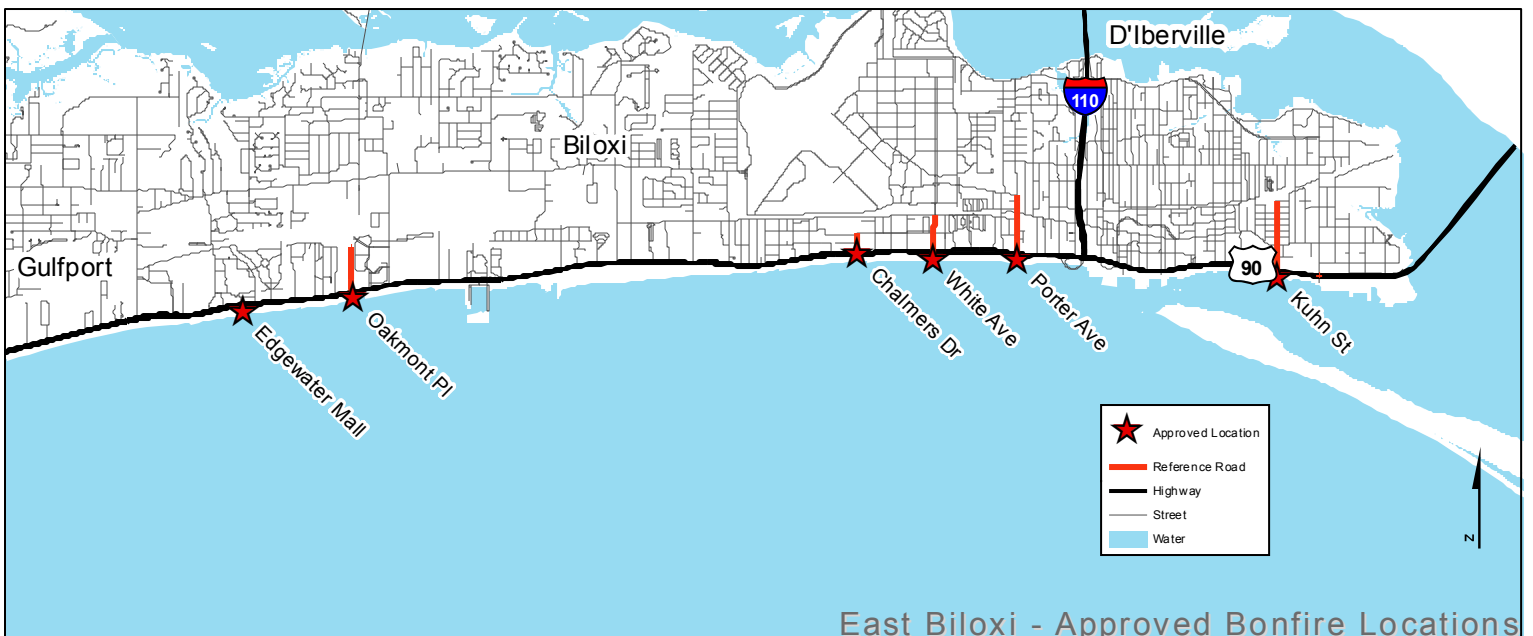
